# Introduction:

The iLink LCD is an Internet downloadable messaging system utilizing state-of-the-art MPEG compression to achieve truly stunning near-CD quality audio storage and playback. All unit management and audio downloads are accomplished by your dealer using a special controller software suite. When an update is needed your dealer connects to the iLink via your high-speed Internet connection and digitally transfers the MP3 audio files and configuration settings you need. Changes can be initiated on demand, scheduled from minutes to weeks, or the iLink can be instructed to connect automatically and load new audio. With the Local Record option users can record up to 16 message slots, set interval time and select internal or external background music sources all from LCD interface.

# Unpacking and Inspection:


Before you begin installation, unpack and verify you have all the correct parts.

 Ethernet cable
 RCA to RCA cable
 RCA to 3.5mm adapter
 Wall mount screws
 Instruction manual
 Microphone (Local Record Option Only)

If you are missing any of these parts STOP and call your dealer.

# iLink Layout Summary:

### **Front of Unit**




12VDC - This is where the supplied 12VDC @ 500mA power pack is connected.

POWER - Use this switch to turn the unit ON and OFF.

MIC - Microphone input for Local Recording (Optional). Uses a standard 1/8" type computer microphone.

LAN - This jack connects to the local Ethernet that allows the iLink connectivity to the Internet. The jack also has two built in LEDs that report back network activity and speed status.


#### **Rear of Unit**



CHANNEL A or B (IN) - This signal level jack allows an external BGM (Background Music) source to be fed through the iLink unit.

CHANNEL A or B (OUT) - This jack connects to a phone systems MOH input or a PA amplifier.

 $8\Omega$  or  $600\Omega$  - This switch changes the output impedance of the CHANNEL A or B (OUT) jack.





MENU BUTTON - Keypad button used to cycle through menu items.

SELECT BUTTON - Keypad button used to select menu item to be changed.

UP and DOWN BUTTONS - Keypad buttons used to make changes to selected items.

2 x 16 LCD - White lettering on blue backlighting LCD used to display unit information.





Pressing MENU advances through menu selections.

Pressing SELECT chooses menu option to be changed.

Note:

Changes to IP Settings only available in STATIC MODE

If MAIN MENU item is idle for more than 90 seconds the LCD reverts back to MAIN SCREEN

If SUB MENU is idle for more than 90 seconds the LCD reverts back to MAIN SCREEN and CANCELS any current changes.

#### LOCAL RECORD OPTION - LCD Menu (Feature on Channel A Only)

Before recording make sure microphone is plugged into unit.

#### Local Record

1. Press MENU until the LOCAL SLOTS screen is on the LCD.

2. Press SELECT

3. On the SELECT SLOT menu the selected slot will have a "+". Press the  $\bigvee \blacktriangle$  arrows until the slot that is to be changed has a "+".

4. Press SELECT

5. ON the SELECT MODE menu press the ▼▲ arrows to choose the record, play, activate, deactivate or delete function to be used in that slot.

6. Press SELECT and the following action on that slot will occur.

a. RECORD 🛛 🗕	-> RECORDING <- SELECT to Stop ↓

Recording Tips:

Recording should be performed about 6 to 8 inches from the microphone. Maxiumum time of 45 seconds per slot is available for recording. After RECORD function - slot will be placed in DEACTIVATED Mode.

#### Interval

1. Press MENU until the LOCAL INTERVAL is on the LCD.

2. Press SELECT.

3. Press the ▼▲ arrows to select interval time from 1 to 3600 seconds. Hold ▼▲ arrows to increment or decrement interval time faster.

4. Press SELECT to accept change.

1. Press MENU until the LOCAL BGM SOURCE is on the LCD.

NOTE: If setting BGM source to INTERNAL then the NTL Studio control software must be used to select the BGM playback content.

Default Setting : BGM EXTERNAL

### Web Browser (Feature on firmware version 07.09.x or higher)

The iLink LCD has a built-in password protected web browser that will display the units serial number, firmware version and MAC address. This browser will also allow the units communication mode, connect-back address and port to be changed.

	Press "Submit" to make changes to the unit. Leave "New Settings" blank if there is no change.	

When changing *Mode* either DHCP or STATIC must be typed in the "New Settings" column. When changing to STATIC mode the IP, Subnet and Gateway must all be entered or the settings will not take when submitted. The *Status* will indicate if the settings have been updated to the unit.

# **Installation :**

Step 1: Wall or shelf mount the unit. Rubber feet and screws are supplied in the accessory kit.

*Step 2:* Verify the power switch on the right side of the unit is set to OFF. Attach the included power pack to a wall or power strip receptacle, then attach the other end to the jack on the right side of the unit labeled 12VDC.


*Step 3*: Make sure any amplifiers (if using any) are turned OFF prior to any connections.

*Step 4:* Connect a RCA cable (supplied in the accessory kit) to the CHANNEL A (OUT) jack on the left side of the unit. Connect the other end of the RCA cable to a phones MOH port, PA amplifier or speaker. For dual output applications follow the same procedure for the CHANNEL B (OUT).

*Step 5*: (Optional) For messaging only applications the existing BGM (Background Music) can be fed through the iLink. Connect the audio source to the CHANNEL A or B (IN) jack(s) on the left side of the unit. This jack must only be fed signal level audio - ANY AMPLIFIED AUDIO WILL DAMAGE THE UNIT.

*Step 6:* Connect an Ethernet cable (supplied in the accessory kit) to the LAN jack on the right side of the unit. Connect the other end to a 10/100 speed switch or hub.

# **Connectivity Test:**

Step 1: Verify the power switch on the right side of the unit is set to ON.

Step 2: On the LCD menu verify unit has a valid IP, subnet, gateway, connect-back & port.

Step 3: On the LCD menu go to the "PRESS UP ARROW TO CONNECT-BACK" and press the UP ARROW.

Step 4: The LCD will display the "FORCING CONNECT PLEASE WAIT"

*Step 5:* If there is a Connect-Back record waiting for the unit then the LCD will display "ACTIVE CONNECT XXX.XXX.XXX.XXX.



If there is no record waiting then it will display "CONNECT TO XXX.XXX.XXX.XXX" for one second on the LCD to confirm a successful connectivity.



# Channel A & B Output Level Adjustments:

Step 1: Verify CHANNEL A or B (OUT) is connected to either a phone's MOH port, PA amplifier or speaker.




Step 2: Verify the unit is playing audio by listening to the internal monitor speaker.



▼▲ Cycles Internal Speaker to OFF, A or B

Step 3: Depending upon the device the  $8\Omega/600\Omega$  switch may need to be pushed to better match the impedance of the device the iLink is driving.



*Step 4:* Adjustment of the <u>stored audio</u> output level can be done through the LCD and Menu. Depending upon the application either call into the phone system and be placed on hold OR listen to the PA systems speakers to fine tune volume.




If you see a "LOCKED VOLUME SETTINGS" message then the dealer has locked this setting.

Step 5: All volume adjustments are applied live so changes are saved to the unit instantly.

# Channel A & B Input: BGM Feedthrough Level Adjustments (Optional):

Step 1: Plug feed from an <u>unamplified</u> external background music source to the CHANNEL A or B (IN)



Step 2: Verify the unit is playing audio by listening to the internal monitor speaker.


